
## SECTION E CERTIFICATION

Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.



Elevations shown hereon are relative to the National Geodetic Vertical Datum (N.G.V.D.) of 1929 based on Bench Mark 35 and 36 with a published elevation of 30.763 feet and 31.275 feet, respectively as shown on the right-of-way map for Upper Manatee River Road.

This residence is under construction and not finished. Elevation of lowest floor taken at top of stemwall.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones.

Elevations for all A Zones should be measured at the top of the reference level floor.

Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
