

Structure lies within the A Zones; The vents are within a 1' of the interior floor level. The A/C units are elevated. C2e is the lower side of the elevated A/C pads. Per FEMA definition this is not considered to have an attached garage. (There is an electrical outlet within the enclosed area at elevation 11'). There are six "Smart Vents" total in the Garage Doors (Model #1540-524, SN #56003476) . 6-Engineered vents of 42 total.
