SECTION E CERTIFICATION



COMMENTS: Foundation location only. This residence is under construction. The lowest floor elevation is 30.41 feet NGVD. This subdivision has been filled above existing ground. Initial elevation at center of lot was 25.7.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
